Greetings District 8, An update from my July report; my action item to recon all monthly balance sheets for 2024 was completed and all updated balance sheets were sent out by the District Secretary on June 25th, 2024. It was found while reconciling that I was unaware I was to be paying Unity Center monthly for use of their space. A check was submitted to them for March through August in the amount

Our starting balance for this reporting period was \$2,409.51.

Total debits for the month amounted to \$691.80 which included Answer Iowa for \$235.40, Century Link for \$40.70, Dreamhost for \$5, Unity Center Mar thru Aug rent for \$150, Unity Center Sep rent for \$25, Annual PO Box fee of \$170 and DCM - gas/mileage for \$65.70. Total deposits for the month amounted to \$495.70 of which \$430.00 was from 4 group contributions. The remaining \$65.70 was a deposit from the DCM to reimburse unused Gas/Mileage that was debited earlier in the month.

Our ending balance is \$2,213.41.

Our prudent reserve is \$1,500.00 which leaves us an available balance of \$713.41.

Our literature account has a balance of \$535.00.

- Elections for all District 8 Chair positions for the term of 2025-2026 will be held at next month's business meeting. At this time I have asked Joe P. to go over all service positions and their description.
- ☐ Joe P. moved to amend the Service Positions Job Description (SPJD) and Guidelines documents for District 8 Guidelines Chair as follows:
 - The SPJD document Description for this position should be changed to "The District 8 Guidelines Chairperson is an advisory member of the District 8 Committee. As such, this position is not eligible for travel reimbursement as are other committee chairs, nor does this position command the \$25/monthly budget as do other committee chairs."
 - The SPJD document Selection and Qualification Requirements for this position should be changed to "Must be an active member of Alcoholics Anonymous, with a minimum of five years of continuous sobriety. Additionally, this individual should have a minimum of four years of service in District 8 to ensure familiarity with the Guidelines. Elected by the membership of District 8 in even years for a two-year term. However, in the case that this position remains empty the District 8 Chairperson should appoint an individual to hold the position until such time as the position can be filled by election."
 - In the District 8 Guidelines, the opening words of Item 4 in the section District Expenditure and Budgeting should be changed to "Reimbursement will be \$.45 cents per mile to District Officers and Service Chairs, with the exception of the Guidelines Chair, ..."

- In the District 8 Guidelines, the opening words of Item 5 in the section District Expenditure and Budgeting should be changed to "Service Chairs, and the District Secretary, with the exception of the Guidelines Chair, have a monthly budget of \$25.00 Joe P.
 - \checkmark Motion seconded by Wes Y. One vote in the minority. The minority spoke, with no motion from the majority to reconsider.

Concept VIII (Kyle T.)

Short Form: Each group has but one primary purpose—to carry its message to the alcoholic who still suffers.

The trustees are the principal planners and administrators of over-all policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities. **Long Form:** The Conference recognizes that the Charter and the Bylaws of the General Service Board are legal instruments: that the Trustees are thereby fully empowered to manage and conduct all of the world service affairs of Alcoholics Anonymous. It is further understood that the Conference Charter itself is not a legal document: that it relies instead upon the force of tradition and the power of the A.A. purse for its final effectiveness.

Next Meeting: Concept IX (Ross H.)

Short Form: Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.

Long Form: Good service leaders, together with sound and appropriate methods of choosing them, are at all levels indispensable for our future functioning and safety. The primary world service leadership once exercised by the founders of A.A. must necessarily be assumed by the Trustees of the General Service Board of Alcoholics Anonymous.
